## GROUP PROGRAM AGREEMENT

\_\_\_\_\_ (participant name), thank you for joining Tonya Rutter (Tonya Rutter, Tonya Rutter Coaching, Nyx House Press, Nyx House Media, collectively the “Company”) for The New You Blueprint (the “Program”), which begins \_\_\_\_\_ [date] and ends \_\_\_\_\_ [date].

This is your contract. *Please read it carefully before signing, because you are making an important commitment to Tonya Rutter.*

### THE BASICS

1. You are securing one of a limited number of places Tonya Rutter offers in this round of The New You Blueprint.
2. The Price is \$995 (US Dollars), payable upfront or two (2) payments of \$550 for a total of \$1100 or three (3) payments of \$375 for a total of \$1125. A nonrefundable deposit of \$375 has been received and will be applied to your balance; this deposit holds your space in The New You Blueprint.
3. By joining right now, you are also receiving this bonus: A gift of crystals from One Peace Sanctuary.

4. We make it easy to understand what it is like to do business with Tonya Rutter. Please check out the Company Policies before signing this Agreement. Those policies are part of this Agreement even though they are not spelled out in this document.

5. This Agreement, the Company Policies and Disclaimers, Facebook Group rules, and the Credit Card Authorization are the entire agreement between us. These written documents supersede our prior discussions, emails, online or voice messages. By signing, you agree that there is no information that you deem materially important that is not incorporated into this Agreement.

### **THIS IS WHAT YOUR GROUP PROGRAM INCLUDES**

1. **Two (2) 1-on-1 Coaching sessions.** You are invited to one (1) 60-minute kickoff one-on-one coaching session during the Program Term, to be conducted virtually (via Skype, Zoom, or appropriate means) or over the phone, along with one (1) 30-minute intuitive one-on-one coaching session during the Program Term. Your attendance is critical for the success of this program and there are limited times available. Therefore, please make your best efforts to make our available days work. You will receive a scheduling link once your payment is received. The purpose of the one-on-one kickoff coaching session is to help you outline your goals for the Program Term utilizing a combination of a Past Life Reading, a Tarot Reading, Dream Interpretation, and any other intuitive outcomes. The 30-minute intuitive coaching session can be used for emergency calls or any other intuitive session including Tarot Reading, Past Life Reading, or Dream Interpretation. These coaching sessions must be used during the Program Term or they are forfeited, and all calls are subject to our business policies regarding coaching session scheduling and cancellation.

2. **30 Days of Email Coaching Support.** During the Program Term, you will email homework for review and can also ask questions. You'll get a response specific to your homework review and/or questions within three (3) business days. Be sure to check out the email policies in the Facebook Group files.

3. **Exclusive Facebook Group.** You will have access to the exclusive Facebook Group, where you can submit questions, files, videos, and any other materials for the group to critique. Tonya Rutter will participate in the Group through the end of 2019 with occasional live streams, question and answer sessions, and other information as the group needs dictate. After graduating from the Program, you will move to an Alumni Group where you will have lifetime access to the Group.

4. **Portal Access.** You receive access to the Tonya Rutter online portal, which includes written materials and video and audio lessons on coaching topics. You will have lifetime access to the written materials.

5. **Group Calls.** You will have access to a weekly group call on Mondays at 7 pm ET for two hours, where Tonya Rutter will be present to present material on homework topics, answer questions, hear from the members on their progress.

### **SCHEDULING POLICIES**

1. To schedule coaching sessions, you may do so from the Tonya Rutter Coaching website. There is no guarantee that our availability will match yours.

2. If you do not attend at the scheduled day and times, your session is forfeited.

3. If you must cancel or reschedule, you must do so at least 1 day in advance, or your session will be forfeited.

4. If we cancel, no-show, or must reschedule, the process and policies will be repeated.

## **THESE ARE \*NOT\* INCLUDED**

1. **Services.** Coaching outside of the realm that Tonya Rutter offers are not included.
2. **Endorsements.** You are not receiving an endorsement from Tonya Rutter Coaching, Nyx House Media, Nyx House Press, or Tonya Rutter, and neither is any other participant. Do not create the appearance of an endorsement or rely on any person who claims to be endorsed by Tonya Rutter.
3. **Ownership of Written Materials.** As a participant, you will have one license to view written materials provided by Tonya Rutter. You do not have ownership of this information, which is protected by federal copyright laws. Some of the information is also protected by a contractual license between the provider and Tonya Rutter, Tonya Rutter Coaching, Nyx House Press, and Nyx House Media. You may not copy, re-engineer, distribute, or otherwise provide access to this information to any other person, for free or paid, without express written consent of Tonya Rutter, which it may withhold for any reason, and purchase of a license (prices start at \$995.00).
4. **Trademark Usage.** Tonya Rutter protects its names! You are not receiving permission to use trade and service marks like Tonya Rutter, Tonya Rutter Coaching, Nyx House Press, Nyx House Media, The New You Blueprint, or any other trademark of the Company, even if not listed here.
5. **Results Not Guaranteed.** You are receiving a space in the program, support and guidance, *but not* guaranteed results from participating in the program.
6. **Confidentiality.** Tonya Rutter cannot guarantee confidentiality. While all participants agree to not share/repeat confidential information during group coaching sessions, Tonya Rutter cannot guarantee another participant will adhere to confidentiality. Do not share any confidential

information which may harm your business or personal interests if repeated, copied, or otherwise transmitted and/or implemented by a third party.

### **Additional Legal Terms**

1. There is a **NO REFUNDS** policy.

By signing this Agreement, you acknowledge that no one has represented to you that refunds are available. Tonya Rutter considers this policy a material inducement to entering into this Agreement, and would not have done so unless this No Refunds policy were included. If you initiate a chargeback, Tonya Rutter may issue an additional **\$250** fee to you.

2. **Disclaimer of Warranties.**

Participant understands the Group Program is offered on an “as-is, where-is” basis, without any implied or express warranty as to its performance or to the results that may be obtained by using the program. This limited warranty is the only express warranty made to you and is provided in lieu of any other express warranties (if any) created by any documentation.

4. **If we get sued due to something you did:**

**8. Tonya Rutter can end your participation in the program.**

Company may determine, in its sole discretion and without requiring disclosure of the reason, that the relationship under this Agreement must terminate. In this circumstance, Company will provide a prorated refund to you as determined in Company policies.

**9. Indiana law governs this Agreement and it will be enforced by either party in Indiana.**

THE PROGRAM(S) IS COPYRIGHTED AND ANY AUDIO AND/OR VISUAL PRESENTATIONS AND MATERIALS PROVIDED TO YOU BY TONYA RUTTER, ITS AGENTS, OR ITS EMPLOYEES OVER THE COURSE OF THE PROGRAM(S), ARE LICENSED TO YOU UNDER THIS AGREEMENT, NOT SOLD TO YOU. BY ATTENDING AND/OR VIEWING THE PROGRAM(S), OR DOWNLOADING, INSTALLING, OR OBTAINING A LICENSE KEY, OR OTHERWISE ACCESSING PROGRAM MATERIAL(S), YOU ACKNOWLEDGE THAT:

- A. YOU HAVE READ THIS AGREEMENT
- B. YOU UNDERSTAND IT
- C. THAT YOU ACCEPT AND AGREE TO BE BOUND BY ITS TERMS



IF AT ANY TIME YOU ARE NOT WILLING TO BE BOUND BY THE TERMS OF THIS AGREEMENT, YOU SHOULD

A. TERMINATE ANY DOWNLOAD AND/OR INSTALLATION

B. TERMINATE ANY DOWNLOAD AND/OR INSTALLATION PROCESS,  
IMMEDIATELY CEASE AND REFRAIN FROM ACCESSING OR USING THE  
PROGRAM MATERIALS

C. DELETE ANY COPIES YOU MAY HAVE

THIS AGREEMENT, ALONG WITH ANY ADDITIONAL TERMS OR POLICIES INCORPORATED HEREIN BY REFERENCE, REPRESENTS THE ENTIRE AGREEMENT BETWEEN YOU AND TONYA RUTTER CONCERNING THE PROGRAM, AND THIS AGREEMENT SUPERSEDES AND REPLACES ANY PRIOR PROPOSAL, REPRESENTATION, OR UNDERSTANDING YOU MAY HAVE HAD WITH TONYA RUTTER RELATING TO THE PROGRAM, WHETHER ORAL OR WRITTEN.

## SECTION 1: THE NEW YOU BLUEPRINT Participation and Program Fees

1.1. THE NEW YOU BLUEPRINT PROGRAM: Under the terms of this Agreement, TONYA RUTTER agrees to provide intuitive life coaching services to YOU in the form of live Program(s), in some instances including Audio and/or Visual Presentations, Documentation, Software, printed or digital Materials (“Program”) in exchange for a Program Fee set forth in Paragraph 1.2. below. More particularly, TONYA RUTTER agrees to provide YOU with certain Deliverables defined as:

- a) Personal access to TONYA RUTTER and THE NEW YOU BLUEPRINT founder Tonya Rutter of TONYA RUTTER COACHING;
- b) Unrestricted access to the full THE NEW YOU BLUEPRINT valued at \$2500
- c) One (1) one-on-one 60 minute Kick-off Call with Tonya of TONYA RUTTER COACHING
- d) One (1) question and answer THE NEW YOU BLUEPRINT client group coaching call per week
- e) Unlimited access to review and critique of materials submitted by YOU for TONYA RUTTER scrutiny during the Program Term
- e) Lifetime access to the THE NEW YOU BLUEPRINT members area, including any all updates made to the Program.

Deliverables are redeemable by YOU within 4 weeks from the commencement of this Agreement according to Paragraph 1.1.1. below. You are responsible for booking your calls via the links number provided in the members area. If unforeseen circumstances arise (such as difficulty processing the Program, needing to take time off from the Program, illness, natural disasters, etc.), the Program Term along with your access to Deliverables may be extended or put on hold at Tonya Rutter's discretion.

#### YOUR ACCESS TO THE DELIVERABLES

1.1.1. TERM: The Term of this Agreement will commence upon YOUR acceptance of this Agreement and payment of the Program Fee in Paragraph 1.2. below.

1.1.2. TERMINATION: Either Party to this Agreement may terminate this Agreement at any time upon written notice to the other Party. This Agreement will continue in perpetuity until such

notice of termination occurs. Paragraph 3.1. below shall survive Termination of this Agreement, binding YOU to Confidentiality in perpetuity.

1.2. THE NEW YOU BLUEPRINT PROGRAM FEE: By accepting the terms of this Agreement, YOU agree and understand that you are committing to pay TONYA RUTTER one (1) payment of \$995 or two (2) payments of \$550 for a total of \$1100 or three (3) payments of \$375 for a total of \$1125. In special circumstances, alternative payment arrangements can be made on a case-by-case basis at Tonya Rutter's discretion. A non-refundable deposit of \$375 has been received and will be applied to your balance. No access to the Program will be granted until all fees have been paid. To keep your account in active status, it is recommended that you make payments towards your balance as funds become available. If your account is inactive for 30 days, i.e. no payments made, the retail price of \$2500 will take effect. NO REFUNDS WILL BE ISSUED EVEN IF YOU DON'T ATTEND THE PROGRAM, AS A SPACE IS BEING HELD FOR YOU.

1.2.1. NO REFUNDS: TONYA RUTTER abides by a strict, no refund policy. By accepting the terms of this Agreement, YOU agree and understand that you are foregoing the right to claim any refund of fees paid for access to the Program and any related Audio and/or Visual Presentations, Documentation, Software, printed or digital Materials offered by TONYA RUTTER. YOU agree and understand that in the event that either Party affects Termination of this Agreement according to Paragraph 1.1.2. above, any Fees already paid to TONYA RUTTER will not be refunded. However, YOU will no longer be responsible for paying any Fees pending per Paragraph 1.2. above. YOU further acknowledge that in accepting the terms of this Agreement and affirmatively seeking the benefits of and membership in such Program, YOU are taking full responsibility for YOUR OWN success. Thus, YOU agree that you will not request a

FAILURE TO PAY: Should your second or third payment (or any other payment arrangements made) not process successfully, you will have 5 business days to contact TONYA RUTTER and provide an alternative form of payment. If no payment is made, then Paragraphs 1.2 and 1.2.1 above will take effect.

LIMITED LIABILITY: In no event will TONYA RUTTER be liable to YOU or any party related to you for any damages, including damages for loss of income, employment, mental, physical or other pecuniary loss, whether under a theory of contract, warranty, tort (including negligence) products liability or otherwise, even if TONYA RUTTER has been advised of the possibility of such damages. Limitations herein described shall be applied to the greatest extent enforceable under applicable law.
